NO TRACE – You do not have any convictions, cautions, final warnings or reprimands.

NO LIVE TRACE – Whilst there is criminal record information held about you, this information does not appear on your Police Certificate(s) as it is deemed no longer relevant. It still forms part of your criminal history and it is your responsibility to declare it in accordance with the conditions of your visa application.

FURTHER INFORMATION STEPPED DOWN – Only relevant criminal record information is shown on the Police Certificate(s).
